 - Director Decoteau reminded the HR Community that there will be a quarterly HR Community meeting after the September 7th Commission meeting and that there will be a representative with the Wage and Hour Division from the Department of Labor to discuss FLSA updates.
 - Director Decoteau informed the Commission that the Governor issued Executive Order JBE16-32 implementing a freeze on the ability of unclassified employees within the executive branch of state government to receive merit increases.
