SUBJECT: Announcement of September 18, 2018 Pay Hearing

****This pay hearing was previously scheduled on September 5, 2018.
It was cancelled due to the threat of Tropical Storm Gordon.****

The State Civil Service Commission will hold a public hearing on Tuesday, September 18, 2018, to consider proposed changes to the Classification and Pay Plan. The hearing will begin at 9 a.m. and will be held in the Louisiana Purchase Room of the Claiborne Building, 1201 Third Street, Baton Rouge, Louisiana.

The Commission will consider the following exhibits:
