TO: Heads of State Agencies and Human Resources Directors

SUBJECT: Announcement of May 3, 2023 Pay Hearing

The State Civil Service Commission will hold a public hearing on Wednesday, May 3, 2023, to consider proposed changes to the Classification and Pay Plan. The hearing will begin at 9:00 a.m. and will be held in the Louisiana Purchase Room of the Claiborne Building, 1201 Third Street, Baton Rouge, Louisiana.
